#### 5. Fire-fighting measures

#### 6. Accidental release measures

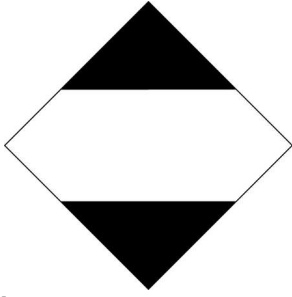
